**TERMS**

The undersigned owner or officer hereby certifies that the information as furnished on this Credit Application is true and correct to the best of his/her knowledge, and that this information is being furnished to American Discount Aluminum, Inc. (hereinafter called ADA, Inc. Vinyl Division) for the purpose of inducing ADA Inc. Vinyl Division to extend credit to the Applicant; and that ADA, Inc. Vinyl Division is entitled to rely upon this information.

The Applicant agrees as follows:

- 1) That the term of the credit extension is and shall remain "Net 30" - meaning the whole balance of the Invoice shall be paid within 30 days from the date of sale.
- 2) Any unpaid balances over 30 days shall be subject to a late charge of up to 1.5% interest per month, not to exceed the maximum rate permitted by law.
- 3) To pay all costs of collection which ADA, Inc. Vinyl Division may incur to collect any outstanding balance, including reasonable attorney's fees and court costs, whether or not suit is brought.
- 4) The exclusive venue of any action between ADA, Inc. Vinyl Division and the Applicant regarding any matters between them including collection activity, will be Leon County, State of Florida.
- 5) That this Credit Application, as well as the terms of each Invoice and any transaction between ADA, Inc. Vinyl Division and the Applicant, shall be governed by and construed in accordance with the laws of the State of Florida.
- 6) To secure all amounts due ADA, Inc. Vinyl Division from the Applicant, the Applicant does hereby grant to ADA, Inc. Vinyl Division a security interest in all merchandise purchased from ADA, Inc. Vinyl Division.
- 7) The Applicant understands and agrees that no warranty whatsoever is given on any products unless expressly set forth in writing. As such, ADA, Inc. Vinyl Division does not provide any oral warranties and no person is authorized to give any warranties on behalf of ADA, Inc. Vinyl Division.
- 8) The only written warranty issued by ADA, Inc. Vinyl Division with regard to sale of Angle Iron Covers is the guarantee that we will replace any defective product, provided that the Applicant returns the product for our inspection.
- 9) ADA, Inc. Vinyl Division has no liability for any damages to shipped product. The Applicant must inspect the product at delivery and at that time refuse any product that was damaged in route. Once the Applicant signs for delivery of product, ADA, Inc. and its contracted Carrier are not held liable for any damaged product.

The Applicant understands that ADA, Inc. Vinyl Division will retain this application whether or not an account is established or a line of credit is approved. The Applicant herein gives ADA, Inc. Vinyl Division the authority to investigate the credit history of the Applicant and its trade and bank references for all normal credit information and authorizes ADA, Inc. Vinyl Division direct contact with the listed bank for further financial information.

Furthermore, in regards to any credit extended to the Applicant, the undersigned absolutely and unconditionally guaranties the full and prompt payment to ADA, Inc. Vinyl Division of all amounts due or hereafter to become due from the Applicant, including any costs of collection set forth in the above referenced paragraphs.
